All riders are responsible for their own camping and State Park day use fees.

Camping is primitive and water is limited. Shower house will be open in the park.

AWARDS: 1-6<sup>th</sup> places, Grand & Reserve champion (limited & open) and completion to all who qualify.

All riders will be eligible for a prize drawing at the end of the ride.

GENERAL RULES

Negative Coggins test within one year required

Entries open to all horses, ponies, and mules

Animals must be at least 3 years of age to do 15 miles and at least 4 years of age to do 25 miles

Horses should be capable of a 5+ mph pace

No liniments, drugs, or wraps will be allowed

Boots may be worn for completion only

Any kind of tack is okay

Electrolytes, feed supplements, and insect repellents are okay

Jr. Riders under age 18 need a signed parent/guardian release as well as predetermined riding adult sponsor

All are required to wear a riding helmet

TRAILS: dirt and hilly

DIRECTIONS: From highway 73 take 67 North to Jct 64 spur, go east to Park

From highway 75 turn east on 62 turn north on 67 to Jct 64 spur go east

From highway 136 go south on 67 turn east on Jct 64 spur. Follow MOTDRA signs

AFTER YOU GET TO THE PARK We will be camping at the "special use area". Stay on the road you came into the park on at the gate. Go past the one-way road and past the horse trail head parking area. You will go down a long steep hill with a curve to it. When the road levels and straightens out you will see the special use area to your left. There will be a sign there, "special use area"
